

# Release of Liability Athlete

1. As a SWISSMAN participant I agree to abide by the regulations set out in the SWISSMAN manual along with the requirements of the organizers according to the briefing. Every breach of the SWISSMAN regulations observed by the SWISSMAN crew leads to immediate disqualification.
2. **I know that I may start SWISSMAN only if I have a registered supporter, who is responsible for my support during the whole event. In addition, the supporter transports my equipment.**
3. I know and agree that during SWISSMAN and related activities I bear the sole responsibility for my personal possessions and athletic equipment with the exception of a small backpack during the clothing transport to the Kleine Scheidegg. This backpack contains no valuables.
4. I confirm that I am physically fit for the SWISSMAN and have sufficiently trained for this event and my physical condition has been certified by a doctor.
5. I hereby agree that a doctor or member of the SWISSMAN crew can prohibit the continuation of SWISSMAN when he diagnoses the risk of damage to my health or a threat to road safety. Should medical treatment be necessary during the event I declare in advance my consent with these measures. Medical treatments are not included in the entry fee and participant directly charged according to the general medical rates. It is in the responsibility of the participant to ensure adequate insurance coverage for medical treatments. A liability of the organizer is thus excluded.
6. I will follow the instructions of the SWISSMAN crew. I know and accept that I have to retire from SWISSMAN if I do not reach the designated cut-off times.
7. I am prepared to enter the race with technically immaculate equipment.
8. I give permission to have my name and photo used by the media free of charge and without restriction if this is done in connection with SWISSMAN.
9. I am aware that participation in the SWISSMAN involves the risk of serious injury. Even fatal accidents cannot be ruled out.
10. I exempt the organizers and volunteers of the SWISSMAN from any liability if they are not covered by legal liability. Included are all direct and indirect damages that I, my heirs or other legal successor as well as third parties could claim arising out of sustained injuries or death.
11. I exempt the organizers and volunteers of the SWISSMAN from any liability or indemnification held by third parties, where such third party suffered damages in connection with my participation in the SWISSMAN.
12. I agree to indemnify the organizer for all sanctions (fines, penalties and other costs) that arise due to my offenses against legal or official regulations and rules.
13. I accept that the organizer may be forced to cancel the event or change the routes or program due to external forces or due to official orders. Further claims cannot be asserted.
14. I accept that if the SWISSMAN is cancelled by 31 March 2022 due to higher force or official restrictions, the entry fees will be refunded with deduction of a processing fee of 200 CHF. After 31 March 2022 no entry fees will be refunded.
15. In the case of disputes, the applicable law is exclusively Swiss law. Place of jurisdiction is Zurich, Switzerland. I accept that the organizer may be forced to cancel the event or change the routes or program due to external forces or due to official orders. Further claims cannot be asserted.
